Terms & Conditions

Equipment requirements: Air source heat pumps and air to water units must be listed on the air source Heat Pump Qualified Product List. See MassSave.com/HPQPL. Integrated controls must be listed on the Integrated Control Qualified Product List. Refer to MassSave.com/ICQPL. Ground source heat pumps must be ENERGY STAR certified and qualified, listed with and certified by the Air Conditioning, Heating and Refrigeration Institute (AHRI), and meet the program EER and AHRI outdoor unit configuration requirements (where applicable).

Application form: This application must be filled out completely, truthfully and accurately. The customer must date and submit the completed application along with all required documentation for specific rebates and/or incentives. By submitting the rebate application, the customer agrees to abide by these Terms and Conditions. Program is subject to change without prior notice, including rebates and incentive levels.

Time limit: Qualifying units for equipment rebate must be purchased and installed between January 1, 2025 and December 31, 2025. Applications must be postmarked by February 28, 2026.

Payments: From the time the application is processed and approved, please allow 6-8 weeks for payment. Payment processing will take longer if information or documentation is missing from the application. For customers that wish to designate their rebate payment directly to their contractor, contractors must first register with and be approved by the Sponsors of Mass Save. If contractors are not registered and approved, or if the pavee information is different from the account holder information, additional time will be needed for payee verification.

Geographic requirements: Offers valid only for residential customers in Massachusetts where Cape Light Compact, Eversource, National Grid or Unitil is the Sponsor.

Rebate limitations: This rebate is only available to existing account holders. Installation must be completed by a participating Mass Save HPIN contractor to be eligible for rebates. This rebate is only available to residences that are occupied full time during the winter heating season. This rebate may not be combined with any other utility or energy efficiency service provider offer for the same equipment. This limitation does not apply to the HEAT Loan financing program. Other, non-Mass Save rebates or incentives may also be used. Rebate amount not to exceed the total installation cost and may be subject to change without notice.

Proof of purchase: A copy of the customer's invoice listing the total cost by system of the purchased equipment must accompany each rebate application form. The invoice must indicate the equipment make, condenser and indoor unit model numbers, size in tons, installation date and address, total install cost and proof of payment.

Approval and verification: The participating Sponsor reserves the right to conduct field inspections to verify installations prior to payment.

Tax liability: Sponsors will not be responsible for any tax liability that may be imposed on the customer or contractor as a result of the payment of rebates.

Endorsement: Sponsors do not endorse any particular manufacturer, product, system design or technology in promoting these offers.

Limitation of liability: Sponsors and their rebate administrator's liability is limited to paying the rebate and incentive specified. 2025 Enhanced residential heat pump rebates

Save with rebates on heat pumps installed by a contractor participating in the Mass Save® Heat Pump Installer Network (HPIN) between January 1, 2025 and December 31, 2025.

Offer only for heat pumps replacing existing oil, propane or electric resistance as the primary heating source. Rebate not to exceed purchase price. Limit one (1) rebate per home, maximum of \$25,000.

How it works

- Verify enhanced rebate eligibility: Verify that your household income meets the eligibility requirements before submitting this form. Visit MassSave.com/Enhanced or call 866-527-7283 to get verified. Cape Light Compact customers should call 800-797-6699 to get verified.
- 2. Weatherize your home*: All weatherization updates recommended for your home during the Home Energy Assessment must be completed prior to applying for the enhanced rebate. All weatherization work is available at no cost for income verified customers.
- Work with a Mass Save heat pump installer: Heat pumps work best when correctly sized and designed for your home. Working closely with a qualified contractor will help ensure your system is designed to meet your heating and cooling needs. Find a qualified installer at MassSave.com/ FindAHeatPumpInstaller
- Consider financing: Interested in 0% financing? Apply for a Mass Save HEAT Loan prior to installing your equipment. Learn more at MassSave.com/HEATLoan
